1. INFORMATION ABOUT US

Tishri Records Inc. is responsible for handling personal information collected through this Website.

2. INFORMATION WE COLLECT

We collect information necessary to provide services, process orders, communicate with customers, improve the Website, and operate our business.

The types of information we may collect include:

A. Information You Provide Directly

You may provide information when you:

- Purchase merchandise;

We may receive limited transaction information, such as:

- Order information;
- Payment status.

For payment security reasons, we do not have access to your complete credit or debit card information.

5. INFORMATION COLLECTED AUTOMATICALLY

This information may include:

You may disable cookies through your browser settings. However, disabling cookies may affect certain Website features.

7. ANALYTICS

We may use analytics services to understand Website usage and improve our services.

Analytics providers may collect information such as:

- Device information;
- Browser information;
- Website activity;
- Approximate geographic information;
- Referral information.

Analytics information is generally collected in an aggregated or anonymized manner.

Analytics services do not provide us with sensitive personal information unless voluntarily provided by you.

8. EMAIL MARKETING AND COMMUNICATIONS

If you voluntarily provide your email address, we may use it to send:

- Artist updates;
- New music announcements;

- Album releases;
- Merchandise announcements;
- Special promotions;
- Newsletters.

You may unsubscribe from promotional emails at any time by:

We may still send transactional communications relating to purchases, including:

- Order confirmations;
- Shipping notifications;

9. HOW WE USE YOUR INFORMATION

We may use collected information to:

- Process and fulfill orders;
- Deliver digital downloads;

- Respond to customer inquiries;
- Send requested communications;
- Improve Website functionality;
- Analyze Website performance;
- Prevent fraud;
- Maintain security;
- Comply with legal obligations;
- Enforce our Terms & Conditions.

We do not sell your personal information.

10. HOW WE SHARE INFORMATION

We may share information only as necessary to operate our business, including with:

11. DATA RETENTION

We retain personal information only for as long as reasonably necessary for legitimate business purposes, including:

When information is no longer needed, we may securely delete or anonymize it.

12. DATA SECURITY

However, no method of electronic transmission or storage is completely secure. We cannot guarantee absolute security.

13. YOUR PRIVACY RIGHTS

17. California Right to Correct

California residents may request correction of inaccurate personal information maintained by the Company.

18. California Right to Opt Out of Sale or Sharing

Tishri Records Inc. does **not sell personal information**.

We do not sell your personal information to:

- Data brokers;
- Advertisers;
- Marketing companies;
- Third parties for monetary compensation.

We also do not share personal information for behavioral advertising purposes beyond ordinary website analytics or services necessary to operate the Website.

19. California Right to Limit Use of Sensitive Personal Information

The Company does not intentionally collect sensitive personal information as defined under California law, such as:
